1. Introduction

This Directive is provided to ensure safe and efficient groundside vehicle activities and parking at the Airport.

This Directive provides ground transportation operators with the requirements that apply to various areas of the Air Terminal Building (ATB) frontage road and sets out requirements for parking activities at YLW. It is intended to provide fair and equitable access to the facility and provide the traveling public with exceptional service in a safe and secure environment.

2. Curb Operations

Air Terminal Building (ATB) curb operating procedures are detailed in Appendix A.

The ATB Curb Operating Map can be found in Appendix B.

3. Employee Parking

YLW provides the necessary guidance for staff working in the YLW ATB in regards to parking their own vehicles on the groundside of the Airport. Detailed procedures can be found in <u>Appendix C</u>.

4. Fuel Management

The airport operates two fuel dispensing areas on the airport:

 Glycol Facility: Provides both diesel and regular gasoline for use by YLW vehicles and for approved tenant vehicles that don't go off airport (tugs, tractors, etc).

• The second fuel tank system provided by the airport is the regular gasoline dispenser located in the car rental service center. This fuel is for the use of on-site car rental vehicles only.

Detailed procedures are located in <u>Annex 1 Fuel Management</u>.

Airside vehicle policies and procedures are located in AD 004 Airside – General.

1. General

There are multiple areas along the Air Terminal Building (ATB) frontage designated for the various ground transportation and service providers at YLW. These areas have appropriate signage and will be strictly enforced.

YLW's curb is pay for use by commercial operators. The rate structure can be found on the City of Kelowna website (<u>Airport Fees Bylaw</u>).

Failure to abide by posted signage and the terms of this directive may result in bylaw enforcement action and/or suspension or cancellation of the violator's airport license.

YLW recognizes the passenger's right to choose. If at any time a passenger chooses one mode of transportation over another, or chooses one vehicle over another, that passenger shall not be refused service.

Ground transportation providers and their staff are permitted to use the air terminal building; however, loitering and business solicitation are not permitted.

In order to offer exceptional customer service to the travelling public, drivers must be at their vehicles prior to passengers entering the arrivals area. If drivers are not present at their vehicles, the next vehicle may be taken.

The City of Kelowna and YLW have adopted an <u>anti-idling policy</u> for all City-owned vehicles. Ground transportation operators are encouraged to follow suit, and promote this clean air policy by ensuring that vehicles are not left idling.

There are two areas on the east curb designated for passengers with disabilities. These areas are used for the drop off and pick-up of passengers with disabilities or for passengers that require special assistance. Disabled parking placards are not mandatory; however, Airport Security will monitor the area to ensure it is being used appropriately. These areas are identified by signage and blue curbside markings.

The Airport Security contractor has full authority to uphold the terms of this policy. Seasonal differences to this circular will be communicated through Special Operations Notices.

2. Licensed Taxis

A Trip Fee is applicable for both pick-up and drop off of customers at the YLW terminal.

Short trips less than 3 km from the airport are not subject to the trip fee. A passenger cannot be refused service based on the length of trip.

There are three taxi staging areas at YLW as shown in Appendix B:

- Pickup Area maximum 3 vehicles at the yellow curb outside of arrivals
- **Staging Area** maximum per pavement markings and signage located at the south end of the ATB frontage road
- Overflow on Convair Place

3. Licensed Limousines

The licensed limousine staging zone is located on the West curb of the ATB frontage road as shown in Appendix B.

• Maximum of 2 limousines per operator at the yellow curb

4. Licensed Pre-Arranged Ride Services (TNS and Taxis)

A Trip Fee is applicable for both pick-up and drop off of customers at the YLW terminal curb front.

Short trips less than 3 km from the airport are not subject to the trip fee. A passenger cannot be refused service based on the length of trip.

Pre-arranged pickups for taxis are permitted, but the driver and his vehicle must be parked in the licensed pre-arranged ride services. The driver must have a confirmation of their passenger name and flight number to occupy a spot. This location will be used by pre-arranged taxi services, as well as Transportation Network Services (TNS) operators and licensed limousines.

The licensed pre-arranged pickup zone is located as shown in Appendix B.

5. Shuttles and Buses

5.1 Licensed Shuttles and Buses

There are two staging areas designated for licensed shuttle and bus operators as shown in Appendix B.

Licensed non-scheduled operators will have access to the licensed shuttle and bus staging area for parking and passenger loading and off-loading. Licensed vehicles parked in the licensed shuttle and bus staging area must display a current airport decal.

5.2 Unlicensed Shuttles and Buses

All unlicensed shuttles & buses are to park in the area at the south end as shown in <u>Appendix B</u>. Licensed Baggage Delivery Service

There is a pickup area for licensed baggage delivery service which is shown in Appendix B.

6. Unlicensed Ground Transportation

All unlicensed ground transportation vehicles awaiting pre-arranged pick-ups must park in the overflow hold area shown in <u>Appendix B</u>. Under no circumstances will non-licensed operators be permitted to park anywhere on the ATB frontage road.

The driver must provide the passenger name(s) to the Airport Security officer and wait at the Security counter. Once the passengers have been identified, they may be picked up at the south shuttle and bus staging area.

Unlicensed ground transportation providers are not permitted to pick up walk-up or non-prearranged passengers. Any commercial activity not approved by the airport is unauthorized to use the east or west curbside in any manner other than as outlined in this document.

Parking only as space permits

7. RMCP, Security and CBSA Vehicles

The area designated in <u>Appendix B</u> is reserved for RCMP, Security and CBSA vehicles.

8. Service / Contractor / Delivery Vehicles

Service / contractor and/or delivery vehicles will be parked on a "first come, first served" basis in the Shuttle/Bus parking area when space permits. Alternate parking can be arranged through contacting YLW Security.

9. BC Transit

The BC Transit area is located as shown in Appendix B.

Transit schedules are available at the Tourism Kelowna Desk. Schedules and information can also be found on the BC Transit Kelowna website.

10. Rental Car Operations


All rental cars pick-ups and drop-offs must occur within the rental car ready lot. Rental cars are permitted to be picked up or dropped off on the ATB frontage road to meet the accessibility needs of passengers.

11. CBSA Inspections

CBSA vehicle processing inspections will be conducted in the area as shown in <u>Appendix B</u>.

Employee Parking

1. General

Parking is available for Airport Terminal Building (ATB) employees and authorized aircrew.

There are four parking lots available for employees:

- Employee and aircrew lot
- COB parking lot
- Administration parking lot
- North apron lot

Parking application forms are available from the <u>YLW portal</u>. All applications must be certified by the employer's authorized company official prior to being processed by Airport Administration. Lost or damaged decals must be reported to the issuing office. A new application is required to obtain a replacement decal. Temporary parking permits are available from Airport Security.

Employers are responsible for recovering decals from employees who change or terminate their employment.

Employee parking regulations will be enforced by Airport Security. Vehicles that are in violation of the Terms and Conditions will be subject to removal from the lots at the owner's expense.

2. Administration Parking Lot

Parking in the Administration parking lot is restricted to those with orange, yellow and green approved decals visibly displayed in the window of vehicle.

3. Employee / Aircrew Parking

Parking in the employee and aircrew parking area is restricted to pass holders only and is not transferable without the approval of the Airport Director. Parking restrictions will be enforced 24 hours per day.

In order to meet public parking demands for peak periods, employee and aircrew parking will be moved to the overflow lot as required. Notice will be given to tenants when specific dates for relocation have been determined.

4. Combined Operations Building (COB) Parking

Parking in the COB parking area is restricted to the assignee and is not transferable without the approval of the Airport Director. Parking restrictions will be enforced 24 hours per day. Overnight parking is permitted.

5. YLW (City of Kelowna) Employee Vehicle Parking Policies

The following policies apply for YLW employees who have designated groundside parking areas:

- Employee personal vehicles are not permitted access inside the Restricted Area (RA) without the approval of their supervising Manager
- Extended overnight parking for periods of more than 2 days for COB employees along Airport Way is not permitted to ensure there is adequate parking available for shift employees
- Employee bicycles and E-Bikes that are unlicensed may be walked through NPSV into the COB for parking while the employee is on shift
