TERMS AND CONDITIONS OF PERMIT

- 1. The provisions of the Airport Traffic Regulations shall apply to the owner and operator of a vehicle when using the Employee Parking Lots.
- 2. This Permit and accompanying decal expires:
 - (a) if revoked by the Airport Director;
 - (b) if holder ceases to be employed at this Airport;
 - (c) if holder changed employers at this Airport;
 - (d) if decal becomes damaged or unreadable;
- 3. All expired/revoked/damaged Employee Parking Decals must be returned to the Pass Control Office immediately.
- 4. Decals must be visible and affixed to the lower front right side of the windshield, number facing outward.
- 5. Vehicles that do not display a current valid employee parking decal shall be subject to ticketing and removal from parking lots.
- 6. Vehicles must be parked within marked parking space in the employee lots.
- 7. Driving speed within parking lots is 10 kmh.
- 8. Blocking the entrance or exit of the lot is not permitted.
- 9. City of Kelowna will not be responsible for damage to vehicles using any City of Kelowna operated Employee Parking Lot.
- 10. Accidents, thefts, or losses within employee parking lots should be reported immediately to the Airport Security.
- 11. All vehicles using employee parking lots must be registered and equipped as required by the laws of the Province and Municipality in which the Airport is located.
- 12. No overnight parking is permitted.
- 13. Trailers, campers, and other oversized vehicles are prohibited.
- 14. Pursuant to City of Kelowna Bylaw No. 7982 a non-refundable fee will be charged for replacement of any lost or damaged parking decal.
